On 02/16/2009 I was dispatched to location for a compl about unauthorized union activity in the A concourse. Upon my arrival I met with NWA In-flight Manager Robert MULLEN who stated that he was advised by several NWA employees that representatives from AFA-CWA union were in the A concourse soliciting unauthorized literature and pamphlets regarding the AFA-CWA union. MULLEN advised me that in the following weeks NWA flight attendants would be going through union negotiations. MULLEN escorted me to the office where the AFA-CWA operates out of (Room A2-012C). I interviewed Belea BOWER who is a Council Representative for AFA-CWA. BOWER stated she was unaware of any members of the AFA-CWA passing out any literature or pamphlets regarding the AFA-CWA union. BOWER stated that the union did not possess an airport permit to solicit literature or pamphlets. I advised BOWER that it was against Airport Rules and Regulations to solicit literature and pamphlets without a permit on airport property. BOWER stated that she understood and that she could not control every person who represents the union. BOWER was advised to inform members of the AFA-CWA union of Airport Rules and Regulations. I cleared without further incident.
